## **INFORMATION STATEMENT REGARDING THE PROCESSING OF PERSONAL DATA OF PROPERTY OWNERS AND BENEFICIARIES**

The purpose of this statement is to inform you about the personal data we process in accordance with Article 10 the Personal Data Protection Law No. 6698 (“**Law**”).

### **WHAT ARE THE PURPOSES OF PROCESSING YOUR PERSONAL DATA?**

We process your personal data for the following reasons:

- Mitigating and monitoring the social impact on the community due to the expropriation process within the scope of the “Antalya-Alanya Motorway” Project,
- Establishing communication with title deed owners and beneficiaries, receiving their requests and suggestions,
- Responding to these individuals in line with the requests and suggestions received (“**Purposes**”).

### **HOW AND ON WHAT LEGAL BASIS DO WE COLLECT AND STORE YOUR PERSONAL DATA?**

We obtain your personal data from you and from suppliers.

Your personal data is stored in email inboxes and physical environments accessible only to our authorized personnel.

We process your personal data in accordance with Article 5/2(a) of the Personal Data Protection Law, where it is explicitly provided for by law, Article 5/2(c) for the establishment of contracts, and Article 5/2(ç) where it is necessary for the fulfillment of legal obligations.

### **DO WE SHARE YOUR PERSONAL DATA WITH OTHERS?**

We transfer the personal data we collect to Limak Holding A.Ş. subsidiaries and affiliates due to the presence of joint authorized persons and employees within the country, as well as the joint operation of services and information technology infrastructure and the joint execution of HR processes.

We carry out this transfer because it is mandatory under Article 8/2(a) and Article 5/2(f) of Personal Data Protection Law, within the scope of legitimate interests.

### **WHAT ARE YOUR RIGHTS REGARDING THE PROTECTION OF YOUR PERSONAL DATA?**

Your rights under the law:

- To learn whether your personal data is being processed,
- If your personal data is being processed, to request information about how it is being processed,
- To learn the purpose of processing your personal data and whether your personal data is being used in accordance with the purpose of processing,
- To know the third parties to whom your personal data has been transferred within or outside the country,
- To request the correction of your personal data if it has been processed incompletely or incorrectly,
- Request the deletion or destruction of your personal data within the framework of the conditions stipulated in the relevant legislation,
- Request that the third parties with whom your personal data has been shared be notified of the correction, deletion, and destruction operations carried out in accordance with the relevant legislation,
- Object to a result being produced against you through the analysis of your processed personal data exclusively by automated systems,
- Request compensation for any damage you suffer due to the unlawful processing of your personal data.

#### **HOW CAN YOU EXERCISE YOUR RIGHTS?**

You can submit your requests and inquiries regarding your personal data by;

- Applying in person to Antalya-Alanya Motorway with a valid ID,
- By sending a wet-signed application form and a photocopy of your identity card to Kazım Özalp Mah. Hafta Sk. No: 9 Çankaya, Ankara, or
- By signing with a mobile signature or secure electronic signature and sending an email to the KEP address **antalyaalanyaotoyolu@hs03.kep.tr**,

to Antalya Alanya Motorway.

In accordance with the Circular on Procedures and Principles for Applications to the Data Controller, your application must include your first name, last name, signature (if the application is in writing), Turkish ID number (if the applicant is a foreign national, their nationality, passport number, or ID number, if available), the address of residence or place of work for notification purposes, the e-mail address for notification purposes, if any, telephone number, fax number, and information regarding the subject of the request.

Users filing complaints and suggestions must clearly and comprehensively state the subject of their request in their application, including explanations regarding the rights they wish to exercise and the rights they wish to request. Information and documents related to the application must be attached to the application.

The subject of the request must relate to the applicant personally. If the applicant is acting on behalf of another person, they must be specifically authorized to do so, and this authorization must be documented (power of attorney). In addition, the application must include identity and address information, and documents verifying the identity must be attached to the application. Requests made by unauthorized third parties on behalf of others will not be considered.

Requests submitted without complying with the form and content requirements stipulated by the law and relevant subordinate legislation may not be considered by Antalya Alanya Highway.
